Arconic Board Approves Quarterly Dividends

NEW YORK, April 21, 2017 – The Board of Directors of Arconic (NYSE: ARNC) today declared (a) a dividend of 93.75 cents per share on Arconic’s \$3.75 Cumulative Preferred Stock (“Class A Stock”), payable on July 1, 2017, to the holders of record of the Class A Stock at the close of business on June 9, 2017; and (b) a dividend of \$6.71875 per share on Arconic’s 5.375% Class B Mandatory Convertible Preferred Stock (“Class B Stock”), payable on July 1, 2017, to the holders of record of the Class B Stock at the close of business on June 15, 2017. The dividend on the Class B Stock is equivalent to a dividend of \$0.671875 per Depositary Share (each Depositary Share representing a 1/10th interest in a share of the Class B Stock).
